# Privacy Policy

## • WHO AND WHAT THIS POLICY APPLIES TO

- C Tweed Electrical (**we, us** or **our**) provides the products and services offered on the website [www.ctweedelectrical.co.uk](http://www.ctweedelectrical.co.uk) (**Website**).
- For the purposes of the *Data Protection Act 1998* and *General Data Protection (Regulation)*, we are the data controller.
- We have adopted this policy to ensure that we have standards in place to protect the data that we collect about you that is necessary and incidental to:

## • THE INFORMATION WE COLLECT

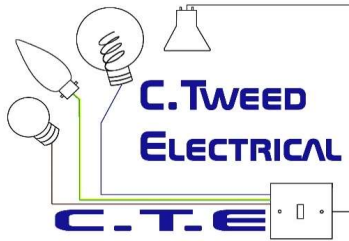

- We will retain data for the period necessary to fulfil the purposes outlined in this policy unless a longer retention period is required or permitted by law (for example financial or certification purposes).
